Together with its donors, the Santa Barbara Foundation distributed \$4.2 million in grants to 321 nonprofit organizations during the second quarter of 2015, bringing its total investments in the community to \$11.8 million this year.

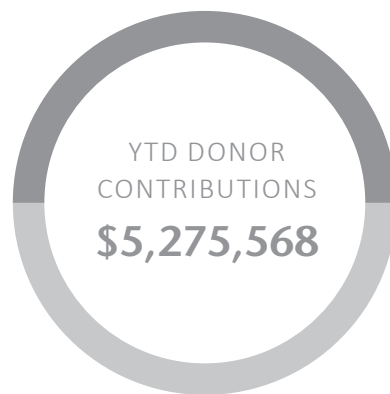
Of the \$4.2 million awarded in the second quarter, \$1.4 million supported health and human services and another \$1.4 million supported the education sector. More than \$3.3 million went directly to nonprofit

organizations serving Santa Barbara County.

Donor contributions totaled more than \$2 million in the second quarter, bringing year-to-date contributions to more than \$5 million.

The Santa Barbara Foundation's quarterly reports provide a quick snapshot of the many ways we are working to strengthen philanthropy in our county and beyond. Thank you to the generous donors and community partners who make this work possible.

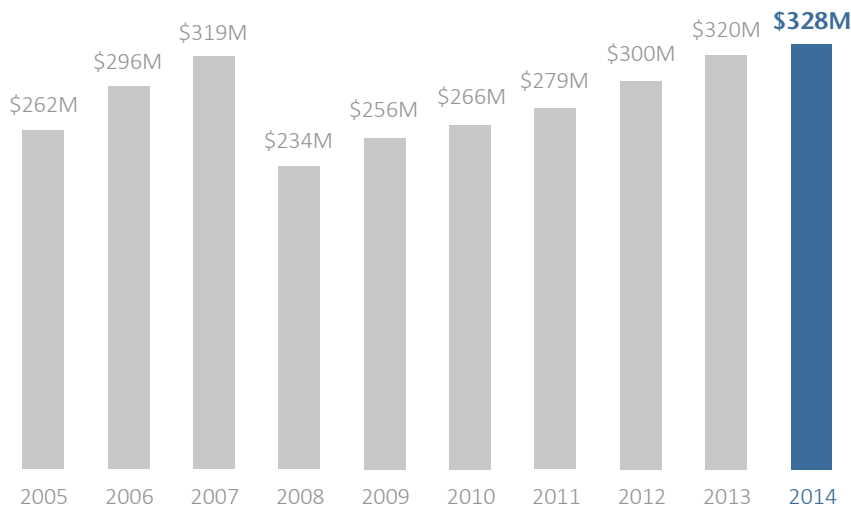

SOLVING COMMUNITY CHALLENGES

Foundation Distributes \$500,000 for Basic Needs

The Santa Barbara Foundation recently awarded \$500,000 in grants to 18 nonprofit organizations providing critical safety-net services in Santa Barbara County. Core Support for Basic Needs Grants were available to nonprofit organizations offering direct assistance in the areas of food, shelter and health care (including behavioral health).

The foundation received proposals from 24 nonprofits throughout Santa Barbara County. After a comprehensive application and interview process, 18 organizations were selected by a committee comprising foundation staff and community experts from North and South County.

“The Santa Barbara Foundation has a dedicated history of prioritizing support for the most vulnerable members of our communities,” said Ron Gallo, president



and CEO of the Santa Barbara Foundation. “Over the past several years, our county has faced an increase in demand for basic needs services. The foundation will continue to partner with the many organizations that work every day to address those challenges.”

Leadership Programs Bolster Nonprofit Effectiveness

Recognizing the value of leadership development and striving to create a more engaged Santa Barbara County for all, the Santa Barbara Foundation is pleased to support three key leadership programs this year.

The **Board Leadership Institute** (pictured right) is offered in partnership with the Ventura County Community Foundation. The five-month program is designed to enhance board leadership and the capacity of the organization to carry out its mission.

The **Katherine Harvey Fellows** program, established by the Santa Barbara Foundation and facilitated by Leading From Within, is an 18-month leadership development program focusing on four primary components: education, values exploration, grant making, mentoring and relationship-building.



The **Emerging Leaders Program**, also facilitated by Leading From Within, is designed to help nonprofit leaders increase their impact both within their organization and the sector at large. This 10-month program combines a professionally relevant curriculum with support in making community connections.

Women's Fund Celebrates 11th Presentation of Grants

The Women's Fund of Santa Barbara awarded grants totaling \$460,000 to seven nonprofit agencies at its 11th annual Presentation of Grants in May. This event celebrates the end of the annual Women's Fund grant cycle and honors its newest grantees, voted on by a membership of 677 women.

This year's grantees included: **Children's Resource & Referral of Santa Barbara County, Community Action Commission of Santa Barbara County, Conflict Solutions Center, Mental Wellness Center, New Beginnings Counseling Center, Sarah House and Transition House.**

"Our Women's Fund reflects a growing national trend of collective giving groups and centers on a simple, creative model – women combining our charitable donations so we can make a larger impact in the



community than most of us would be able to do on our own," said Sallie Coughlin of the Women's Fund.

Since it began in 2004, the Women's Fund of Santa Barbara has awarded grants totaling more than \$5.1 million to 71 local nonprofit programs impacting more than 85,000 women, children and families.

Daniel Fund Provides Critical Child Care Scholarships

To assist working families in Santa Barbara County who face financial hardships, the Santa Barbara Foundation distributed \$295,000 in child care scholarships throughout the county in June. The scholarships were granted through the donor designated fund of William and Lottie Daniel, who wished to support low-income families during and beyond their lifetime.

With full-time child care costing low- to moderate-income households 27 percent to 66 percent of their earnings, these scholarships ensure that more children have access to quality educational experiences. This year, child care scholarships were awarded to: **Carpinteria Unified School District, Girls Incorporated of Carpinteria, Girls Incorporated of Greater Santa Barbara, Hope Community Church, Isla Vista Youth Projects,**



Santa Maria Valley YMCA, St. Mary of the Assumption, St. Vincent's Institution and United Boys and Girls Clubs of Greater Santa Barbara County (pictured above).

The scholarships were granted to licensed child care facilities throughout the county that follow the best practices in child development.
