Your Community Foundation at Work

The Santa Barbara Foundation's quarterly reports provide a snapshot of the many ways we are working to advance philanthropy in our county and around the world. In the third quarter of 2015, the Santa Barbara Foundation and its donors distributed \$3.9 million in grants to 253 nonprofit organizations, bringing its total investments in the community to \$16 million this year.

Education and youth development organizations received more than \$2 million in grants, and more than

\$3.4 million went directly to nonprofit organizations serving Santa Barbara County.

Donor contributions totaled more than \$3.5 million in the third quarter, bringing year-to-date contributions to more than \$9.9 million. Additionally, 10 new funds were opened at the foundation.

All of this work is done alongside our supporters and community partners. Together, we are enriching the lives of people in Santa Barbara County through philanthropy.

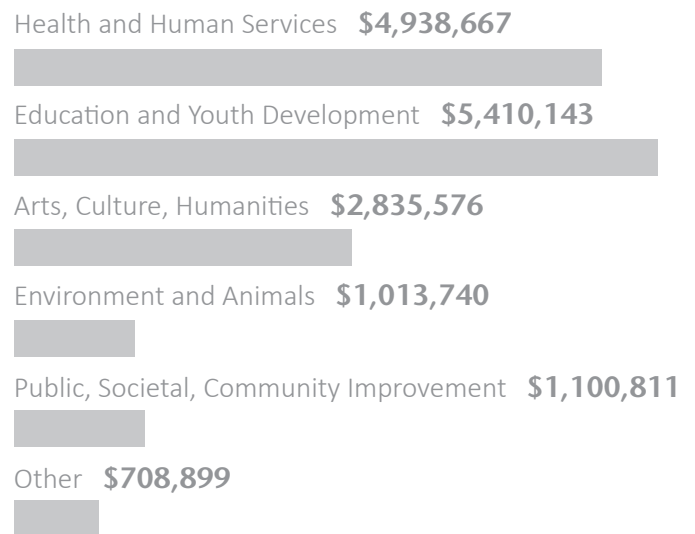

North County Women's Fund Awards Three Key Grants

The Women's Fund of Northern Santa Barbara County recently held its 7th annual grants reception, awarding a total of \$75,450 to three nonprofit organizations to support and expand their services.

Central Coast Literacy Council received \$35,450 for its program to empower adults through English literacy, Friends of the Los Alamos Public Library received \$20,000 to fund start-up items for the newly re-opened library, and the Santa Maria Valley YMCA received \$20,000 to fund a part-time position for a certified teacher to implement the Y-Reader program at Oakley Elementary School.

The Women's Fund of Northern Santa Barbara County is a field of interest fund at the Santa Barbara Foundation. The fund responds to the community's most



urgent needs by making substantial gifts on behalf of the women, children and families in Northern Santa Barbara County. EnergyPartners Provides \$110,000 for STEM Education

The EnergyPartners Fund, a committee advised fund at the Santa Barbara Foundation, recently awarded \$110,000 in grants for educational programs focusing on science, technology, engineering and math (STEM).

The first of these grants went to support the Family Ultimate Science Exploration nights at UCSB, helping underrepresented students and their families gain familiarity with the practice of science, its importance in education, and its promise of exciting career options.

A second grant was jointly funded by the EnergyPartners Fund and Highland Santa Barbara Foundation, Inc. to support the second year of Reasoning Mind in the Santa Maria-Bonita School District. Reasoning Mind is a computer-based mathematics program designed to engage students in developing



critical thinking, reasoning and logic skills.
