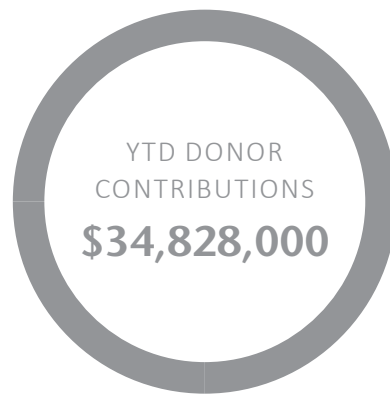
As the community's trusted source for philanthropy, the Santa Barbara Foundation is excited to share highlights of its work from the fourth quarter of 2015.

Together with its donors, the foundation awarded more than \$5.9 million in grants to 532 nonprofit organizations from October to December. More than \$2 million of these grants supported education and youth development programs, and \$1.8 million supported health and human services.

The foundation's community work is generously supported by donors throughout Santa Barbara County and beyond, who contributed more than \$23.3 million during the fourth quarter alone – a record high for donor contributions.

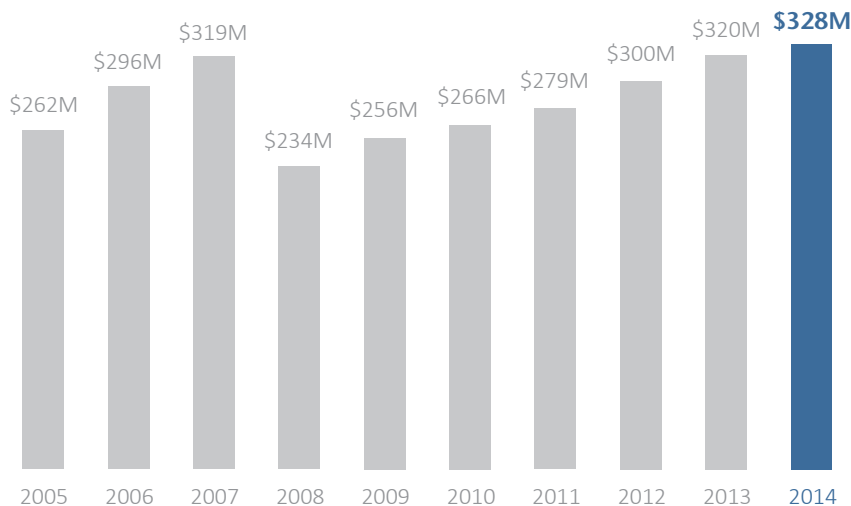

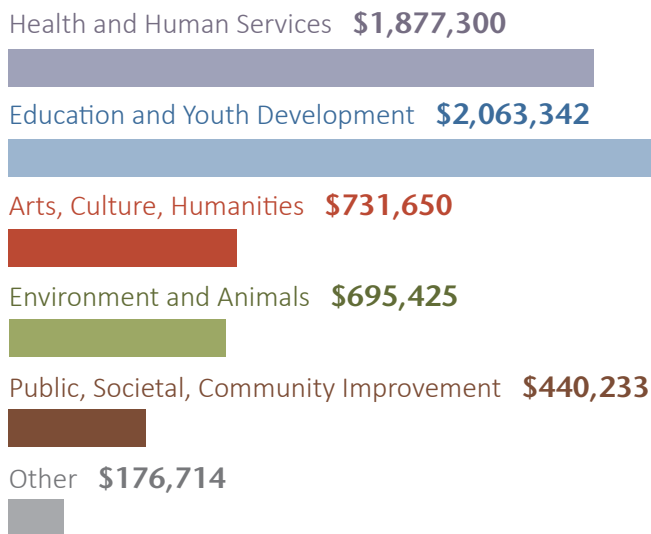

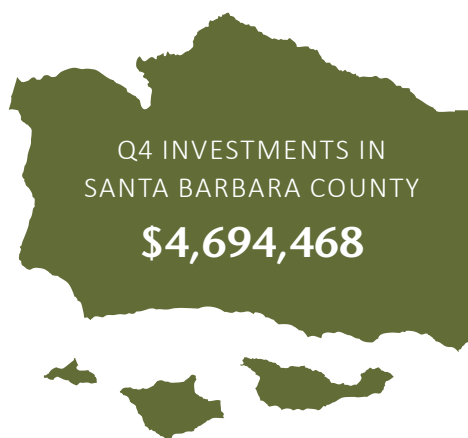
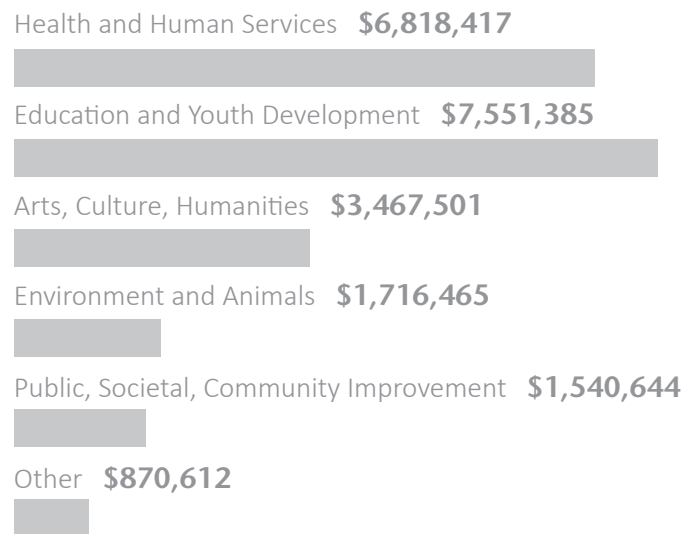

SOLVING COMMUNITY CHALLENGES

Caregiver Initiative Advances Support for Elders and Families

In Santa Barbara County, 70,000 unpaid caregivers provide care valued at \$624 million annually. The Santa Barbara Foundation is committed to innovative solutions that support people who need care and the people who care for them.

The Caregiver Initiative will establish effective caregiver support systems through the development of cross-sector networks of community organizations, including but not limited to health, social and education sectors.

The foundation is focused on the backbone of the long-term care system—family caregiving. Currently, 87% of long-term care is provided by unpaid family caregivers—people who often don't self-identify as caregivers.

By partnering with individuals, families, local communities, nonprofits and others, the foundation is addressing challenges brought on by an aging population and increased longevity.

Foundation Awards Capital Grants Totaling \$300,000

The Santa Barbara Foundation awarded \$300,000 in Capital Grants to 12 nonprofit organizations serving Santa Barbara County. The 2015 Capital Grants program focused on advancing capital campaigns, aligning with the foundation’s commitment to build capacity in the nonprofit sector and leverage philanthropic dollars for critical needs.

“The caliber of this year’s applicant pool was stellar, and we are proud to lend our support to 12 capital campaigns that will create long-term impact in our community and beyond,” said Jan Campbell, chief philanthropic officer for the Santa Barbara Foundation.
